The name of the limited liability company is: JAT Ocala Properties, LLC.

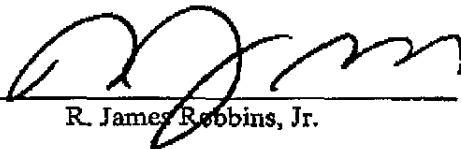
ARTICLE II. ADDRESS
