EXHIBIT "A"

PLAN OF MERGER

THIS PLAN OF MERGER of FIESTA GROVE, a Florida general partnership, and FIESTA GROVE, LLC, a Florida limited liability company, pursuant to Section 608.438 of the Florida Statutes, is adopted as follows:

- A. FIESTA GROVE, a Florida general partnership, shall be merged with and into FIESTA GROVE, LLC, a Florida limited liability company, to exist and be governed by the laws of the State of Florida.
- B. The name of the surviving limited liability or business entity shall be FIESTA GROVE, LLC, a Florida limited liability company.
- C. When this Agreement becomes effective the existence of FIESTA GROVE, a Florida general partnership, shall cease and the surviving entity, FIESTA GROVE, LLC, a Florida limited liability company, shall succeed, without other transfer, to all of the rights and property of FIESTA GROVE, a Florida general partnership, and shall be subject to all of the debts and liabilities of said general partnership in the same manner as if the surviving limited liability company had itself incurred the same. All rights of creditors and all liens on the property of each entity shall be preserved unimpaired, limited to the lien to the property effected by the liens immediately prior to the merger.
