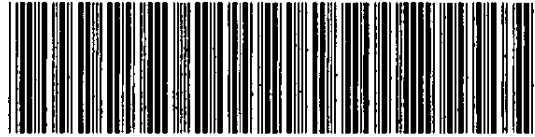

Pursuant to the provisions of section 608.411, Florida Statutes, the undersigned Florida limited liability company duly executes and adopts the following Amended and Restated Articles of Organization. The original Articles of Organization were filed August 18, 2005.


