#### **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be 5821-5831 NW 17TH PLACE, LLC ("Company").

#### **ARTICLE II -- ADDRESS**
