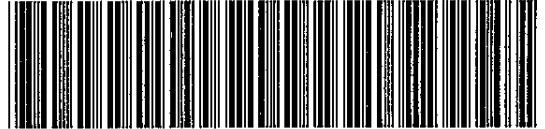


ARTICLE VII


