ARTICLES OF ORGANIZATION OF. BEACH CLUB OPERATIONS, L.L.C.

3 44 83 D 1: 60 The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the

ARTICLE I -- NAME

The name of the limited liability company shall be BEACH CLUB OPERATIONS, L.L.C. ("company").
