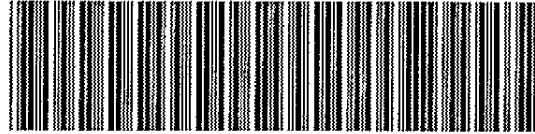

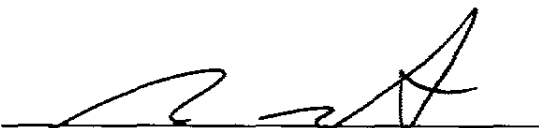
SECOND: Articles of Organization are hereby amended by changing the name of the Corporation to: **Commcare Pharmacy – FTL, LLC**

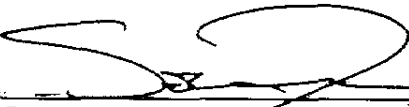
