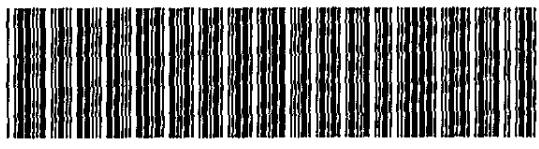



ARTICLE II — Address






