ARTICLE IV: DURATION

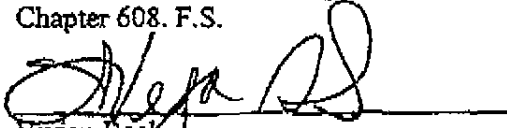

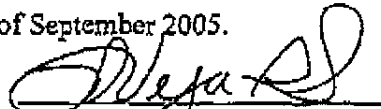

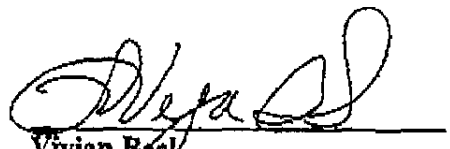
