#### **INDEMNIFICATION**

The rights to indemnification and to the advancement of expenses conferred in this Article V shall not be exclusive of any other right that any person may have or hereafter acquire under these Articles of Organization, the Company's operating agreement, any statute, agreement, vote of the Company's members or the Company's disinterested managers or otherwise. Any repeal or modification if this Article V shall not adversely affect any rights to indemnification and to the advancement of expenses of a manager or officer of the Company existing at the time of such repeal or modification with respect to any acts of omissions occurring prior to such repeal or modification.
