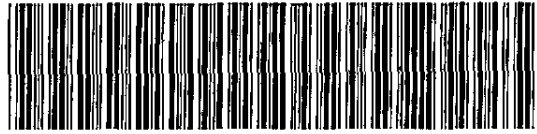

ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, sets forth the following for the purpose of forming a limited liability company under the laws of the State of Florida.

ARTICLE I - NAME




