The following plan of merger, which was adopted and approved by each part for the merger in accordance with section 608.4381, Florida Statutes, is being submitted in accordance with section 608.438, Florida Statutes.

- 1. The exact name and jurisdiction of the merging party is Laura, LLC, a Florida limited liability company, whose address is 13947 Beach Boulevard, Suite 210, Jacksonville, Florida 32224 and whose Florida document/registration number is L05000040133 (hereinafter referred to as the "Absorbed Company").
- 2.
