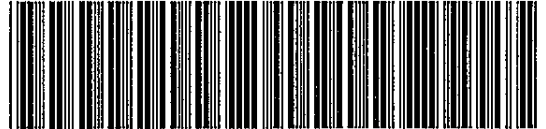

NAME




