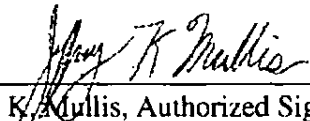
Pursuant to Sections 605.0701 and 605.0707 of the Florida Revised Limited Liability Company Act (the "Act"), the undersigned hereby submits these Articles of Dissolution to the Florida Department of State:

1. The name of the limited liability company is SE Timber LLC (the "Company").
2. The Articles of Organization were filed with the Florida Department of State on October 31, 2005 and assigned Document Number L05000106191, and were subsequently amended by filing Amended Articles of Organization on September 20, 2022.
3. Pursuant to Section 605.0701(1) of the Act, dissolution is authorized pursuant to Section 8.1(b) of the Company's Operating Agreement dated March 31, 2006 which provides that the Company shall be dissolved upon the sale, transfer, or assignment of substantially all of the assets of the Company. Furthermore, Section 4.1.3.9 of the Company's Operating Agreement provides that the Manager has authorization to "Undertake any action for the dissolving, liquidating, and/or winding up the affairs of the Company."
4. The dissolution of the Company shall be effective as of September 19, 2024 at 12:01 a.m.

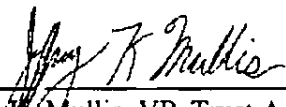
