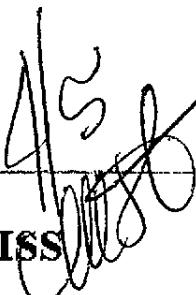

WHEREAS the Members of the Company unanimously consent to the dissolution of the Company.

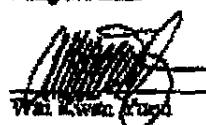
NOW, THEREFORE, BE IT RESOLVED, that:
