ARTICLES OF ORGANIZATION  
OF

REST ASSURED HOME INSPECTIONS, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I  
NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of the Limited Liability Company shall be REST ASSURED HOME INSPECTIONS, LLC ("Company"). The mailing address and principal office of the Company shall be 9100 College Pointe Court, Fort Myers, Florida 33919.

ARTICLE II  
DURATION

The Company shall commence its existence upon the filing of these Articles of Organization, and its existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization.

ARTICLE III  
PURPOSES AND POWERS

The general purpose for which the Company is organized is to conduct real property inspections and to be compensated therefor; to acquire, own, hold, develop, lease, manage, and convey real property; and to conduct other activities incident to same. The Company shall also be authorized to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a Limited Liability Company under the laws of the State of Florida.


ARTICLE IV


