ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LAKE NONA GREENEWAY, LLC

Pursuant to Section 608.411, Florida Statutes, LAKE NONA GREENEWAY, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

FIRST: The Articles of Organization were filed on December 23, 2005, and assigned document number L05000122480.

SECOND: Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "LAKE NONA GREENEWAY, LLC" to "LAKE NONA SOUTH, LLC", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

ARTICLE I - NAME

The name of this limited liability company is LAKE NONA SOUTH, LLC (the "Company").

THIRD: All other provisions of the Articles of Organization remain unchanged and in full force and effect.

FOURTH: The foregoing amendment was adopted by the sole Member of the Company on September 1, 2006.
