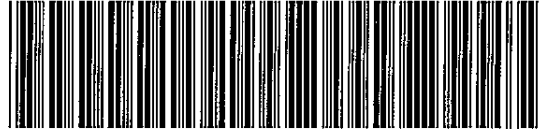



NAME


