ARTICLE IV - The purpose of the Corporation shall be limited to owning, operating, managing and leasing the property commonly known as 10-38 SW 8th Street, Miami, Florida (the "Property") and activities incidental thereto. The Corporation shall be prohibited from incurring indebtedness of any kind other than for the mortgage loan and other indebtedness (the "Indebtedness") incurred in favor of Greenwich Capital Financial Products, Inc., and their respective successors and assigns and its successors and assigns with respect to the Indebtedness ("Lender") and trade payables incurred in the ordinary course of business.

ARTICLE V - The only member of City Center Properties, LLC shall be Trust Fund Holdings, LLC, a Florida limited liability company, 848 Brickell Key Drive, Suite 4405, Miami, FL, 33131.

ARTICLE VI - The following provisions regulate the internal affairs of the Corporation:

1. A unanimous vote of the Member is required to take or cause City Center Properties LLC to take any of the following actions:

- (a) causing City Center Properties, LLC to become insolvent;
  - (b) commencing any case, proceeding or other action on behalf of City Center Properties, LLC under any existing or future law of any jurisdiction relating to bankruptcy, insolvency, reorganization or relief of debtors;
  - (c) instituting proceedings to have City Center Properties, LLC adjudicated as bankrupt or insolvent;
  - (d) consenting to the institution of bankruptcy or insolvency proceedings against City Center Properties, LLC;
  - (e) filing a petition or consent to a petition seeking reorganization, arrangement, adjustment, winding-up, dissolution, composition, liquidation or other relief on behalf of City Center Properties, LLC of its debts under any federal or state law relating to bankruptcy;
  - (f) seeking or consenting to the appointment of a receiver, liquidator, assignee, trustee, sequestrator, custodian or any similar official of City Center Properties, LLC or a substantial portion of properties of City Center Properties, LLC;
  - (g) making any assignment for the benefit of City Center Properties, LLC's creditors; or
  - (h) taking any action or causing City Center Properties, LLC to take any action in furtherance of any of the foregoing;
2. For so long as the Indebtedness is outstanding, City Center Properties, LLC shall not:
- (a) amend the Articles of Organization or operating agreement, if any;
  - (b) engage in any business activity other than as set forth in Article IV; or
  - (d) dissolve, liquidate, consolidate, merge, or sell all or substantially all of City Center Properties, LLC's assets;
3. City Center Properties, LLC shall:
- (a) not commingle its assets with those of any other entity and hold its assets in its own name;
  - (b) conduct its own business in its own name;
  - (c) maintain bank accounts, books, records, accounts and financial statements separate from any other entity;
  - (d) maintain its books, records, resolutions and agreements as official records and separate from any other entity;
  - (e) pay its own liabilities out of its own funds;

- (f) maintain adequate capital in light of contemplated business operations;
- (g) observe all limited liability company formalities;

- (j) not guarantee or become obligated for the debts of any other entity or hold out its credit as being available to satisfy the obligations of others;


