KNOW ALL MEN BY THESE PRESENTS THAT ELBA VILCHEZ AND FERNANDO A GARZON, MEMBERS OF AAA DESIGNS, LLC ARE HEREBY TERMINATED.

Pursuant to the Articles of Organization and corresponding Operating Agreements, in particular the Amended Agreement dated April 27, 2007 which provides among other things, provisions for its Members to be removed by majority vote with or without cause with limited reimbursement of personal invested capital thereof in AAA Designs, LLC (herein after called "The Company") a registered Limited Liability Company in Florida, and

WHEREAS Elba Vilchez and Fernando A Garzon have ignored written agreements detailing exactly the duties each of the Members are to perform, and

WHEREAS Elba Vilchez has existing personal guaranties with J.R. Anderson Real Estate Company, Landlord for the leased premises of "The Company" as well as Norwalk Furniture Corporation, the Franchisor of "The Company", knowing full well that neither guarantee will be affected by this termination and shall remain in full force and effect until and if each respective party issues a release, and

WHEREAS, as a Member of "The Company", Elba Vilchez and Fernando A Garzon are in default of a contractual provision by failing to make certain deposits of additional funds as required and requested numerous times, and

WHEREAS the existence of agreements regarding the division of work, communication and chores between Members have been ignored by Elba Vilchez and Fernando A Garzon evidenced by the course of dealings of the Members of "The Company" prior to the executed Amended Operating Agreement dated April 27, 2007 where that too has been ignored, and
