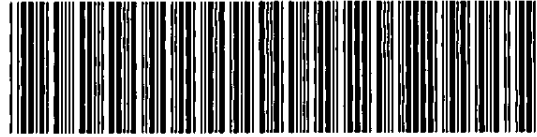

Name**

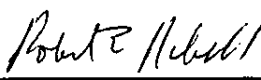
*The name of the Limited Liability Company is **Rocky Comfort Enterprises, LLC**.*
