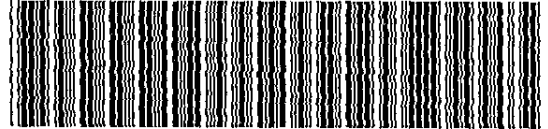

The name of the Limited Liability Company is CLAIRe POINTE DEVELOPERS, (the "Company").


**ARTICLE II - Address**
