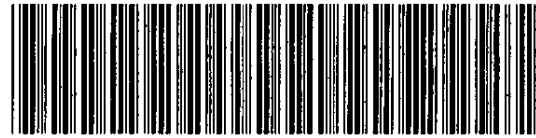

Entrust's address remains the same:


