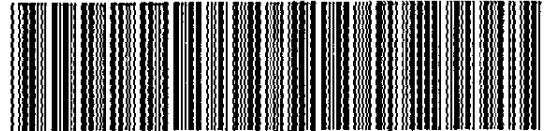

The name of the Limited Liability Company is BC COMMUNICATIONS, LLC (the "Company").

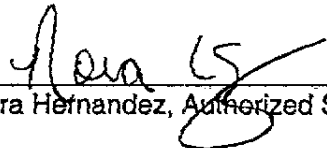
ARTICLE II - Address
