

# ARTICLES OF ORGANIZATION OF TURNER FURNITURE OF TALLAHASSEE A, LLC

These Articles of Organization are made for the purpose of organizing afforida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 508).

# Article 1 - Name

The name of this limited liability company is TURNER FURNITURE OF TALLAHASSEE A. LLC ("Company").

#### Article 2 - Duration

The Company shall exist from the date of filing these Articles with the Department of State until the earlier of thirty (30) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the remaining members pursuant to the Company's Operating Agreement.

#### Article 3 - Mailing Address and Street Address

The Company's address is 317 Industrial Blvd., Thomasville, Georgia 31792.

#### Article 4 - Registered Agent and Office

The name of the initial registered agent of the Company is John C. Lovett. The street address of the initial registered agent of the company is 106 East College Ave., Suite 1200, Tallahassee, Florida 32301.

#### Article 5 – Additional Members

Additional members to the company may be admitted, but only pursuant to the Company's Operating Agreement.

### Article 6 - Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may continue the business of the Company pursuant to the Company's Operating Agreement.

#### Article 7 - Management of the Company

The management of the Company is reserved to the managers. The following person will initially be the manager:

### Article 8 - Operating Agreement

The Members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.

## Article 9 - Date of Existence of the Company

The existence of the Company shall commence on the date of filing the Articles of Organization with the Florida Department of State.
