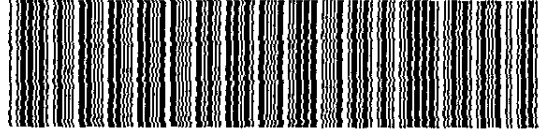

ARTICLES OF ORGANIZATION
OF

KDP PASEO, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be KDP PASEO, LLC ("Company"). The mailing address and principal office of the Company shall be 11270 Mahogany Run, Fort Myers, Florida 33913.

ARTICLE II
DURATION

The Company shall commence its existence upon the filing of these Articles of Organization, and its existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization..

ARTICLE III
PURPOSES AND POWERS

The general purpose for which the Company is organized is to acquire, hold, encumber, develop, lease and sell real property. The Company shall also be authorized to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a Limited Liability Company under the laws of the State of Florida.


ARTICLE IV


