#### ARTICLES OF ORGANIZATION

OF

### SER-LAW, L.L.C.

## (A FLORIDA LIMITED LIABILITY COMPANY)

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

## ARTICLE 1

#### Name

The name of the limited liability company is SER-LAW, L.L.C. (the "Company").

# ARTICLE 2

## Principal Office

The initial mailing address and street address of the principal office of the Company is: 20801 Biscayne Boulevard, Suite 304, Aventura, Florida 33180-1422.

## ARTICLE 3

# Duration

The duration of the Company shall begin with the date of filing of Articles of Organization with the Secretary of State of the State of Florida, and shall be perpetual, or until the Company is sooner terminated in accordance with the terms of these Articles of Organization, the Company's Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms (the "Operating Agreement"), or as otherwise provided by law.

#### **ARTICLE 4**

#### Purpose

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company

shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

# **ARTICLE 5**

#### Members

The Company shall have at least one member and may admit additional members as provided in the Operating Agreement.

#### ARTICLE 6

#### Management

This Company will be managed by one or more managers (each, individually, a "Manager", and collectively, the "Board of Managers") appointed by the Members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The Board of Managers may designated individual Managers as the president, secretary, and treasurer of the Company, and may also designate individual Managers as vice presidents, assistant secretaries, and assistant treasurers, and shall offices shall have the authority normally associated with these positions under corporate law, or as designated by the Board of Managers. The members, at a meeting of the members held not less than annually, shall designate the Managers, who may also be members, and the positions that these Managers will hold. The initial Managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualify, shall be as follows:

#### ARTICLE 7

### Capital Contributions

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the Operating Agreement.

#### ARTICLE 8

### Members Rights to Continue Business

In the event of the resignation, expulsion, bankruptcy, or dissolution of a member of the Company, or the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall continue in existence and the remaining members may

continue the business of the Company unless the majority-in-interest of the then remaining members consent in writing to the dissolution of the Company.

## ARTICLE 9

## Indemnification

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, Manager, or former member or Manager to the full extent permitted under the Act.

## ARTICLE 10

## Initial Registered Office and Agent
