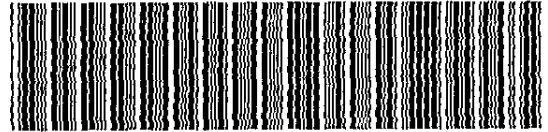



a Florida limited liability company

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization and hereby agree and certify as follows:

ARTICLE I

NAME

The name of the Limited Liability Company shall be 2501 Orange Avenue Partners, LLC (the "Company").

ARTICLE II

ADDRESS

The mailing address and the street address of the principal office of the Company is 255 S. Orange Avenue, Suite 1350, Orlando, Florida 32801.

ARTICLE III

DURATION, PURPOSES, AND POWERS

The period of duration for the Company is perpetual. The purpose for which the Company is organized is to engage in any and all lawful activities permitted under the Florida Limited Liability Company Act. The Company reserves the right to amend or repeal any provision in these Articles of Organization, or any amendment thereto, upon the unanimous written approval of the existing Members of the Company.


ARTICLE VIII

These Articles of Organization will take effect upon filing with the Florida Department of State.

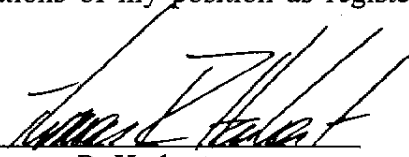
