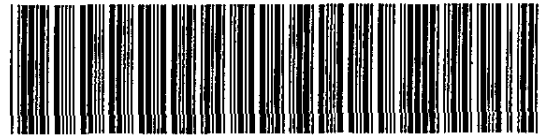

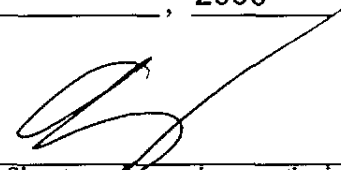
**FIRST:** The Articles of Organization were filed on 2/27/06 and assigned document number L06000021144.
