**PLAN AND AGREEMENT OF REORGANIZATION**  
*By Merger of*  
**NEWJET ENGINE SERVICES, INC.**  
*With and Into*  
**NEWJET ENGINE SERVICES, LLC**  
*As the Surviving Company*

This Plan and Agreement of Reorganization by Merger (hereinafter referred to as the "Agreement") is effective March 8, 2006, by and between **NEWJET ENGINE SERVICES, INC.**, a Florida corporation (hereinafter referred to as the "Merging Company"), and **NEWJET ENGINE SERVICES, LLC**, a limited liability company organized and validly existing under the laws of the State of Florida (hereinafter referred to as the "Surviving Company"). The Merging and Surviving Companies are sometimes referred to in this Agreement as the "Constituent Companies."

This plan of reorganization shall be a tax-free reorganization within the meaning of Section 368(a)(1)(F) of the Internal Revenue Code, as amended.

**WITNESSETH**

**WHEREAS**, the principal and registered office of the Surviving Company is 13945 S.W. 139<sup>th</sup> Court, Miami, FL 33186, and is duly recorded since March 1, 2006; its Registered Agent is John S. Bohatch, 7301 S.W. 57<sup>th</sup> Court, South Miami, FL 33143; and

**WHEREAS**, the principal and registered office of the Merging Company is 13945 S.W. 139<sup>th</sup> Court, Miami, FL 33186, and is duly recorded since February 8, 2001; its Registered Agent is Anton K. Khoury, 13945 S.W. 139<sup>th</sup> Court, Miami, FL 33186; and

**WHEREAS**, the aggregate number of shares that the Merging Company is authorized to issue is 1,000 common shares at \$1.00 per value, of which 1000 shares are issued and outstanding and are owned legally and beneficially by ANTON K. KHOURY and MARYANN KHOURY; and

**WHEREAS**, the Directors, shareholders and members of the Constituent Companies deem it advisable and to the advantage of the Companies and the shareholders and members of both companies that the Merging Company be merged into the Surviving Company on the terms and conditions provided in this Agreement, and in accordance with the laws of the State of Florida;

**NOW, THEREFORE**, in consideration of the premises and of the mutual agreements herein contained, the Constituent Companies have agreed and do hereby agree to merge in accordance with the applicable provisions of the laws of the State of Florida on the terms and conditions stated below.

**ARTICLE I  
PLAN OF MERGER**

**Plan Adopted**

1.01. A plan of merger of **NEWJET ENGINE SERVICES, INC.** and **NEWJET ENGINE SERVICES, LLC**, is adopted as follows:

a) **NEWJET ENGINE SERVICES, INC.** shall be merged with and into **NEWJET ENGINE SERVICES, LLC**, to exist and be governed by the laws of the State of Florida.

b) The name of the Surviving Company shall be **NEWJET ENGINE SERVICES, LLC**

c) When this agreement shall become effective, the separate corporate existence of **NEWJET ENGINE SERVICES, INC.** shall cease (except as otherwise provided for specific purposes as provided by the laws of the State of Florida), and the Surviving Company shall succeed, without other transfer, to all the rights, privileges, powers, franchises, patents, trademarks, licenses, registrations and property, both of a public and private nature, whether real, personal or mixed, of **NEWJET ENGINE SERVICES, INC.** and shall be subject to all the restrictions, disabilities, duties, debts and liabilities of the Merging Company in the same manner as if the Surviving Company had itself incurred them. All rights of creditors and all liens on the property of each Constituent Company shall be preserved unimpaired, limited in lien to the property affected by the liens immediately prior to the merger.

d) The Surviving Company will carry on business with the assets of **NEWJET ENGINE SERVICES, INC.**, as well as with the assets of **NEWJET ENGINE SERVICES, LLC**.

e) The shareholders of **NEWJET ENGINE SERVICES, INC.** will surrender all of their shares in the manner hereinafter set forth.

f) The Articles of Organization of **NEWJET ENGINE SERVICES, LLC**, as existing on the effective date of the merger, shall continue in full force and effect as the Articles of Organization of the Surviving Company until altered, amended, or repealed as provided in the Articles or as provided by law.

**ARTICLE 2**  
**REPRESENTATIONS AND WARRANTIES OF CONSTITUENT COMPANIES**

**Nonsurvivor**

2.01. As a material inducement to the Surviving Company to execute this Agreement and perform its obligations under this Agreement, **NEWJET ENGINE SERVICES, INC.** represents and warrants to the Surviving Company as follows:

a) **NEWJET ENGINE SERVICES, INC.** is a corporation duly organized, validly existing, and in good standing under the laws of the State of Florida, with corporate power and authority to own property and carry on its business as it is now being conducted. **NEWJET ENGINE SERVICES, INC.** is qualified to transact business as a corporation and is in good standing in all jurisdictions in which its principal properties are located and business is transacted.

b) **NEWJET ENGINE SERVICES, INC.** has authorized capitalization of \$1,000.00, consisting of 1,000 shares of common stock, each of \$1.00 par value, of which 100 shares are validly issued and outstanding, fully paid, and nonassessable on the date of this Agreement.

c) All required tax returns of **NEWJET ENGINE SERVICES, INC.**, if any, have been accurately prepared and duly and timely filed, and all taxes required to be paid with respect to the periods covered by the returns have been paid. **NEWJET ENGINE SERVICES, INC.** has not been delinquent in the payment of any tax or assessment.

**Survivor**

2.02. As a material inducement to **NEWJET ENGINE SERVICES, INC.** to execute this Agreement and perform its obligations under this Agreement, **NEWJET ENGINE SERVICES, LLC** represents and warrants to **NEWJET ENGINE SERVICES, INC.** as follows:

a) **NEWJET ENGINE SERVICES, LLC** is a limited liability company duly organized, validly existing, and in good standing under the laws of the State of Florida, with power and authority to own property and carry on its business as it is now being conducted.

b) **NEWJET ENGINE SERVICES, LLC** has Membership Units. As of the date of this Agreement, 1000 Membership Units are validly issued and outstanding, fully paid, and nonassessable.

**Securities Law**

2.03. The Constituent Companies will mutually arrange for and manage all necessary procedures under the requirements of any and all applicable securities laws and the related supervisory commissions, if any, to the end that this plain is properly processed to comply with registration formalities, or to take full advantage of any appropriate exemptions from registration, and to otherwise be in accord with all antifraud restrictions in this area.

**ARTICLE 3**  
**COVENANTS, ACTIONS, AND OBLIGATIONS PRIOR TO THE EFFECTIVE DATE**

**Interim Conduct of Business; Limitations**

3.01. Except as limited by this Paragraph 3.01, pending consummation of the merger, each of the Constituent Companies will carry on their businesses in substantially the same manner as before and will use their best efforts to maintain their business organization intact, to retain their present employees, if any, and to maintain their relationships with suppliers and other business contacts, if any. Except with the prior consent of **NEWJET ENGINE SERVICES, LLC**, pending consummation of the merger, **NEWJET ENGINE SERVICES, INC.** shall not:

- a) Declare or pay any dividend or make any other distribution on its shares.
- b) Create or issue any indebtedness for borrowed money.
- c) Enter into any transaction other than those involved in carrying on its ordinary course of business.

**Submission to Shareholder**

3.02. This Agreement shall be submitted to the shareholders of **NEWJET ENGINE SERVICES, INC.** for approval in the manner provided by the laws of the State of Florida. This Agreement shall also be submitted to the Members of **NEWJET ENGINE SERVICES, LLC** for approval in the manner provided by the laws of the State of Florida.

**Conditions Precedent to obligations of Newjet Engine Services, Inc.**

3.03. Except as may be expressly waived in writing by **NEWJET ENGINE SERVICES, INC.**, all of the obligations of **NEWJET ENGINE SERVICES, INC.** under this Agreement are subject to the satisfaction, prior to or on the Effective Date, of each of the following conditions by **NEWJET ENGINE SERVICES, LLC**:

- a) The representations and warranties made by **NEWJET ENGINE SERVICES, LLC** to **NEWJET ENGINE SERVICES, INC.** in Article 2 of this Agreement and in any document delivered pursuant to this Agreement shall be deemed to have been made again on the Effective Date and shall then be true and correct in all material respects. **Manner**

4.01. The holder of shares of **NEWJET ENGINE SERVICES, INC.** shall surrender all of its shares to the Manager of the Surviving Company promptly after the Effective Date. The surrendered shares shall be canceled and extinguished and in exchange the shareholders of the Merging Company shall have the right to receive Membership Units in the Surviving Company equal in proportion to the shares they held in the Merging Company.

4.02. The currently outstanding Membership Units of NEWJET ENGINE SERVICES, LLC shall remain outstanding.

## ARTICLE 5 DIRECTORS AND OFFICERS

### Manager and Officers of Survivor

5.01. (a) The present Managers of NEWJET ENGINE SERVICES, LLC is ANTON K. KHOURY and MARYANN KHOURY, whose address is 13945 S.W. 139<sup>th</sup> Court, Miami, FL 33186, and shall continue to serve as the Managers of the Surviving Company until the next annual meeting or until his successors have been elected.

(b) If a vacancy shall exist on the Board of Directors of the Surviving Company on the Effective Date of the merger, the vacancy may be filled by the Members as provided by the Operating Agreement of the Surviving Company.

(c) All persons who as of the Effective Date of the merger shall be executive or administrative officers of NEWJET ENGINE SERVICES, LLC shall remain as officers of the Surviving Company until the Board of Directors of the Surviving Company shall determine otherwise. The Board of Directors of the Surviving Company may elect or appoint additional officers as it deems necessary.

## ARTICLE 6 OPERATING AGREEMENT

### Operating Agreement of Survivor

6.01. The Operating Agreement of NEWJET ENGINE SERVICES, LLC, as existing on the Effective Date of the merger, shall continue in full force and effect as the Operating Agreement of the Surviving Company until altered, amended, or repealed as provided in the Operating Agreement or as provided by law.

## ARTICLE 7 NATURE AND SURVIVAL OF WARRANTIES, INDEMNIFICATION, AND EXPENSES OF NONSURVIVOR

### Nature and Survival of Representations and Warranties

7.01. All statements contained in any memorandum, certificate, letter, document, or other instrument delivered by or on behalf of NEWJET ENGINE SERVICES, INC., NEWJET ENGINE SERVICES, LLC, or the stockholder or members pursuant to this Agreement shall be deemed representations and warranties made by the respective parties to each other under the Agreement. The covenants, representations, and warranties of the parties and the stockholders and

members shall survive for a period of three years after the Effective Date. No inspection, examination, or audit made on behalf of the Constituent Companies or the stockholders or members shall act as a waiver of any representation or warranty made under this Agreement.

#### Indemnification

7.02. **NEWJET ENGINE SERVICES, INC.** agrees that on or prior to the Effective Date it shall obtain from the stockholder an agreement under which the stockholders shall indemnify and hold harmless **NEWJET ENGINE SERVICES, LLC** against and in respect of all damages (as defined in this paragraph) in excess of \$5,000.00 in the aggregate. Damages, as used in this paragraph, shall include any claim, action, demand, loss, cost, expense, liability, penalty, and other damage, including without limitation, counsel fees and other costs and expenses incurred in investigating, in attempting to avoid damages or to oppose the imposition of damages, or in enforcing this indemnity, resulting to **NEWJET ENGINE SERVICES, LLC** from (i) any inaccurate representation made by or on behalf of **NEWJET ENGINE SERVICES, INC.** or its stockholders in or pursuant to this Agreement; (ii) breach of any of the warranties made by or on behalf of **NEWJET ENGINE SERVICES, INC.** or the stockholders, in or pursuant this Agreement; (iii) breach or default in the performance by **NEWJET ENGINE SERVICES, INC.** of any of the obligations to be performed by it under this Agreement; or (iv) breach or default in the performance by the stockholders of any of the obligations to be performed by them under any agreement delivered by them to **NEWJET ENGINE SERVICES, LLC** pursuant to this Agreement. The stockholders shall reimburse **NEWJET ENGINE SERVICES, LLC** on demand for any payment made or for any loss suffered by **NEWJET ENGINE SERVICES, LLC** at any time after the Effective Date, based on the judgment of any court of competent jurisdiction or pursuant to a bona fide compromise or settlement of claims, demands, or actions, in respect of any damages specified by the foregoing indemnity. The stockholders shall satisfy their obligations to **NEWJET ENGINE SERVICES, LLC** by the payment of cash on demand. The stockholders shall have the opportunity to defend any claim, action, or demand asserted against **NEWJET ENGINE SERVICES, LLC** for which **NEWJET ENGINE SERVICES, LLC** claims indemnity against the stockholders; provided that (i) the defense is conducted by reputable counsel approved by **NEWJET ENGINE SERVICES, LLC**, which approval shall not be unreasonably withheld; (ii) the defense is expressly assumed in writing within ten days after written notice of the claim, action, or demand is given to the stockholders; and (iii) counsel for **NEWJET ENGINE SERVICES, LLC** may participate at all times and in all proceedings (formal and informal) relating to the defense, compromise, and settlement of the claim, action, or demand, at the expense of **NEWJET ENGINE SERVICES, LLC**.

#### Expenses

7.03. **NEWJET ENGINE SERVICES, INC.** will cause the stockholders to pay all expenses in excess of \$5,000.00 incurred by **NEWJET ENGINE SERVICES, INC.** in connection with and arising out of this Agreement and the transactions contemplated by this Agreement, including without limitation all fees and expenses of **NEWJET ENGINE SERVICES, INC.** counsel and accountants (none of which shall be charged to **NEWJET ENGINE SERVICES, INC.**). If the transactions contemplated by this Agreement are not consummated, either **NEWJET**

ENGINE SERVICES, INC. or the stockholders shall pay such expenses of NEWJET ENGINE SERVICES, INC. as the stockholders and NEWJET ENGINE SERVICES, INC. may then determine. NEWJET ENGINE SERVICES, LLC shall bear those expenses incurred by it in connection with this Agreement and the transactions contemplated by this Agreement.

**ARTICLE 8  
TERMINATION**

**Circumstances**

8.01. This Agreement may be terminated and the merger may be abandoned at any time prior to the Effective Date, notwithstanding the approval of the shareholders of the Constituent Companies:

(a) By mutual consent of the Board of Directors of the Constituent Companies.

(b) At the election of the Board of Directors of either Constituent Companies if:

(1) The number of shareholders of either Constituent Company, or of both, dissenting from the merger shall be so large as to make the merger, in the opinion of either Board of Directors, inadvisable or undesirable.

(2) Any material litigation or proceeding shall be instituted or threatened against either Constituent Company, or any of its assets, that, in the opinion of either Board of Directors, renders the merger inadvisable or undesirable.

(3) Any legislation shall be enacted that in the opinion of either Board of Directors, renders the merger inadvisable or undesirable.

(4) Between the date of this Agreement and the Effective Date, there shall have been, in the opinion of either Board of Directors, any materially adverse change in the business or condition, financial or otherwise, of either Constituent Company.

**Notice of and Liability on Termination**

8.02. If an election is made to terminate this Agreement and abandon the merger:

(a) The President or Operating Manager of either Constituent Company whose Board of Director has made the election shall give immediate written notice of the election to the other Constituent Company.

(b) On the giving of notice as provided in Subparagraph (a) of this Paragraph 8.02, this Agreement shall terminate and the proposed merger shall be abandoned, and except for payment of its own costs and expenses incident to this Agreement, there shall be no liability on the part of either Constituent Company as a result of the termination and abandonment.

**ARTICLE 9**  
**INTERPRETATION AND ENFORCEMENT**




