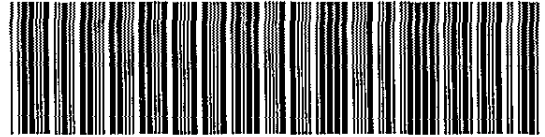

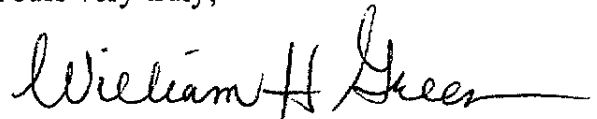

ARTICLES OF ORGANIZATION
