**ARTICLES OF ORGANIZATION OF
JACQUIER FARM AND GARDEN, LLC**

Article I

The name of the limited liability company ("Company") is JACQUIER FARM AND GARDEN, LLC.

Article II

The mailing and street address of the Company's principal office is 30326 County Road 42, DeLand, Florida 32720. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.
