ARTICLES OF ORGANIZATION OF

CLEARFORM, L.L.C.

ARTICLE I - NAME

The name of this Limited Liability Company shall be CLEARFORM, L.L.C.

ARTICLE II - ADDRESS

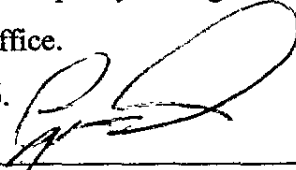
