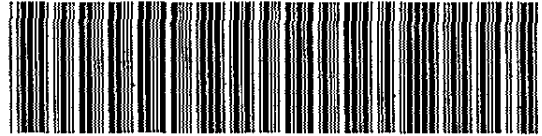

**ARTICLES OF ORGANIZATION**

**OF**

**PRINOVATIVE LLC**

The Member who desires to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, by and through his authorized representative, does hereby adopt the following Articles of Organization and certify

**ARTICLE I: NAME**

The name of the limited liability company is Prinovative LLC (the "**Limited Liability Company**").

**ARTICLE II: ADDRESSES**

The mailing address of the Limited Liability Company is 10263 Gandy Boulevard, #2215, St. Petersburg, Florida, 33702. The street address of the principal office of the Limited Liability Company is also 10263 Gandy Boulevard, #2215, St. Petersburg, Florida, 33702.

**ARTICLE III: DURATION**

The period of duration for the Limited Liability Company shall commence with March 8, 2006 (the "**Effective Date**") and shall continue perpetually, unless terminated (i) by the unanimous vote of all Members of the Limited Liability Company, or (ii) in accordance with the Limited Liability Company's Operating Agreement, if any; provided always, however, that upon any such termination event, the existence and business of the Limited Liability Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Limited Liability Company.

**ARTICLE IV: PURPOSE**

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.



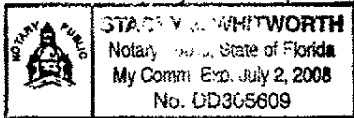
