## ARTICLES OF ORGANIZATION OF RJ Dodgen Construction, LLC

#### ARTICLE I Name of Company

RJ Dodgen Construction, LLC

#### ARTICLE II Business of Organization

The limited liability company may engage in the business of general construction, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE III Principal Place of Business

The principal place of business of the limited liability company shall be: 1628 Nolan Road, Middleburg, Florida 32068, and the mailing address shall be the same.

#### ARTICLE IV Duration

The existence of this limited liability company shall commence April 1, 2006, and thereafter it shall have perpetual existence.

#### ARTICLE V Member-Managed Company
