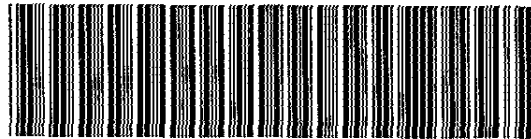

ARTICLES OF ORGANIZATION

THE UNDERSIGNED, being a natural person of at least eighteen (18) years of age and acting as the organizer of the limited liability company ("*Company*") hereby being formed under Article 608 of the Florida Statutes, hereby certifies that:

FIRST: The name of the Company is 10441 ALTA ROAD, LLC

SECOND: The business purpose for which the Company is being formed is to engage in any lawful business activity for which a limited liability company may be organized under the Florida Statutes.
