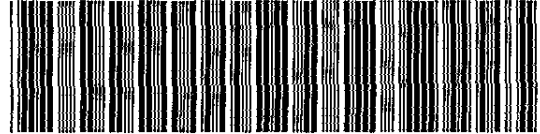

ARTICLES OF ORGANIZATION OF
CV JR BUILDING & DEVELOPMENT, LLC

Pursuant to Chapter 608, Florida Statutes, the undersigned, being a natural person over the age of 18 years, and being a member or an authorized representative of a member of CV JR BUILDING & DEVELOPMENT, LLC, hereby forms a limited liability company.

Article 1
(Name)

The name of the limited liability company is CV JR BUILDING & DEVELOPMENT, LLC.

Article 2
(Duration)

The duration of the limited liability company shall be perpetual.

Article 3
(Initial Principal Office)

The address of the initial principal office of the limited liability company shall be 1042 Shadowmoss Circle, Lake Mary, Seminole County, Florida 32746

Article 4
(Registered Office & Agent)

The address of the initial registered office within the State of Florida for the limited liability company and the registered agent at that address is Randall C. Smith, Esquire, 533 Versailles Drive, Suite 100, Maitland, Florida, 32751.

Article 5
(Additional Members)

No person may be admitted as a member of the limited liability company except upon the unanimous written consent of then existing members of the limited liability company.

Article 6
(Continuation of Business Upon Termination of Member)

In the event of death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, upon unanimous

written consent, the remaining members shall have a right to continue the business of the limited liability company.

Article 7
(Management)

The affairs of the limited liability company shall be managed by one or more managers who shall be elected by and hold such offices as may from time to time be determined by a majority of the members of the limited liability company. The name and address of the initial manager of the limited liability company who shall serve until the first annual meeting or until his successor is duly elected and qualified shall be Charles H. Veigle, Jr., whose address is 1042 Shadowmoss Circle, Lake Mary, Florida 32746.

Article 8
(Transferability of Member's Interest)

No member may assign, in whole or in part, his membership interest in the limited liability company without the unanimous written consent of the non-assigning members.

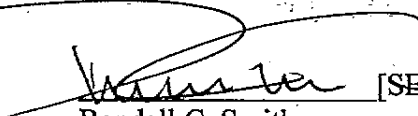
Article 9
(Initial Members)

The company shall have one member initially. The number of members may be increased or decreased from time to time by the Operating Agreement, but shall never be less than one member. 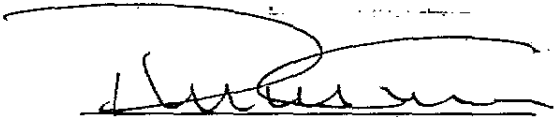
