**ARTICLES OF ORGANIZATION

The undersigned person, acting as the organizer of SRQ INNOVATION GREEN, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:


ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION


ACCEPTANCE OF REGISTERED AGENT
