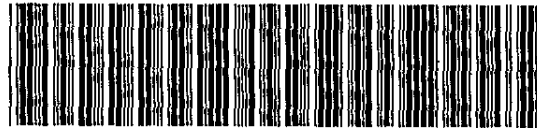

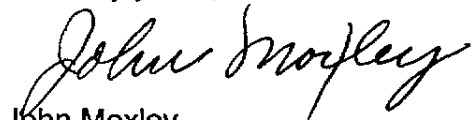

ARTICLE I.

The name of the Limited Liability Company (the Company) is:

ARTICLE V.

The Company is to be a manager/managed company. The initial managers shall consist of two (2) persons and they shall serve until the first annual meeting of the member(s) or at any duly scheduled and announced meeting of the Board of Directors and/or member(s) and the subsequent appointment of the successor managers by the members. The initial managers' names and addresses are:

Managers shall be appointed to serve for two (2) years. However, the length of the terms and the number of managers hereafter shall be determined by the company's Operating Agreement and/or its By-laws.

ARTICLE VI.

The Company shall have two (2) member, namely:

Silver Springs Lions Club, Ocala, Florida
Ocala Fort King Lions Club, Ocala, Florida

ARTICLE VII. Purpose

The purpose of this corporation shall be:

1. The collection, reclamation and recycling of eye glasses and the distribution thereof to developing countries and such other endeavors related thereto and any and all services related to or promoting the helping of the blind and visually impaired worldwide.

2. The company is organized exclusively for charitable and/or educational purposes consistent with each member's 501(c)(3) status under the Internal Revenue Code.

ARTICLE VIII.

The Company is intended to be treated as a branch of its Member for federal and state income tax purposes, except as otherwise required under applicable law. The Company shall take such actions including the making of available tax elections, as are reasonably necessary to insure the Company will be so classified.

This Company is established for the exclusive benefit of the Company, its Member and its successors and assigns. This Company is expressly not intended for the benefit of any creditor of the Company or any other person. Except and only to the extent provided by applicable statute, no such creditor or third party shall have any rights under or against this Company or any agreement between the Company and any Member with respect to any contribution or otherwise.

ARTICLE IX.

In the event of the dissolution of this Company, the residual assets of the organization shall be turned over to the Silver Springs Lions Club and the Ocala Fort King Lions Club located in Marion County, Florida in equal shares in as much as reasonably possible. In the event neither of those organizations is in existence at the time of dissolution of the company, then to such other organization or organizations organized and operated exclusively for educational, charitable and scientific purposes as shall qualify as an exempt corporation company or organization under §510(c)(3) and §170(c) (3) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, of the federal, state or local government for exclusive public purposes.

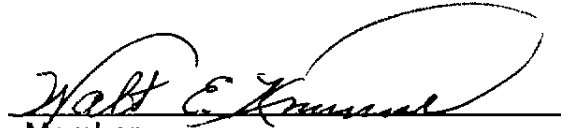
