The Articles of Organization of the Company were originally filed on May 26, 2006.

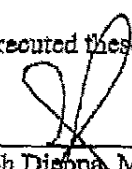

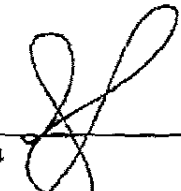
