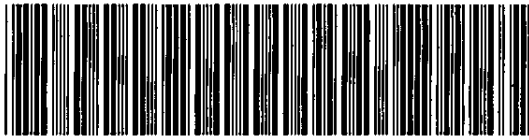

FOR  
FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I  
NAME






