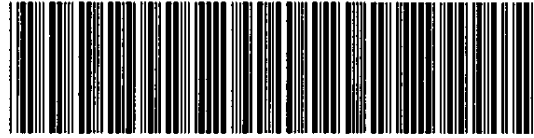

**FIRST:** The Articles of Organization were filed on June 5, 2006 and assigned document number L06000058705.


**SECOND:** This amendment is submitted to amend the following:
