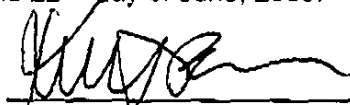

The name of the limited liability company ("Company") is THE PEARL GROUP OF DELAND, LLC.

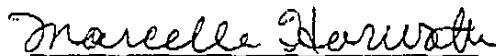
