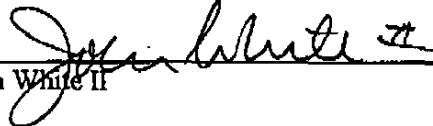

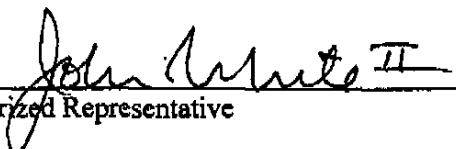
ARTICLE IV
