ARTICLE III- Management:



The persons who are designated or appointed as President or, in his or her absence, a Vice President shall carry out and further the decisions and actions of the managers or member(s) made pursuant to the Operating Agreement and shall be authorized to execute on any and all reports, forms, instruments, documents, papers, writings, agreements and contracts, including but not limited to deeds, bills of sale, assignments, leases, promissory notes, mortgages and security agreements and any other type or form of document by which property or property rights of the Company are transferred or encumbered, or by which debts and obligations of the Company are created, incurred or evidenced, which are necessary, appropriate or beneficial to carry out or further such decisions or actions.

ARTICLE IV- Purpose:

The purposes for which the Limited Liability Company is formed are (a) to promote the social welfare of handicapped, special needs and/or disabled children and adults who are residents of Central Florida by operating a community baseball league at one or more locations located within the City of Orlando which are selected from time to time by the manager(s) and approved by the member, and (b) to further support its member in its charitable, nonprofit activities through the use of any lawful, not for profit business that may be engaged in by a limited liability company organized under the Florida Limited Liability Company Act, as such not for profit business activities may be determined by its Member from time to time.
