ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned authorized representative, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

ARTICLE I - Name

The name of the limited liability company created hereby ("the Company") is: Triple "R" Cable, LLC

ARTICLE II - Purpose

The Company's purpose shall be to engage in any lawful business activity. The Company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, without limitation, all powers permitted by the Florida Limited Liability Company Act.

ARTICLE III - Address

The mailing address and street address of the principal office of the Company shall both b

ARTICLE IV - Duration

The total number of membership units authorized to be issued by the Company shall be 10,000 units. All membership units then issued shall be paid for and shall be nonassessable.

ARTICLE VIII - Admission of Additional Members

Additional members may be admitted to the Company in accordance with the terms and provision the Operating Agreement of the Company.

ARTICLE IX - Registered Office and Agent
