

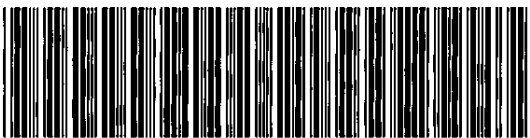

**ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME:

The LLC is to be managed by one or more managers, as provided for in the LLC Operating Agreement and is, therefore, a manager-managed company. No member or other person has been appointed or elected as a managing member of the LLC at the date of the filing of these Articles.

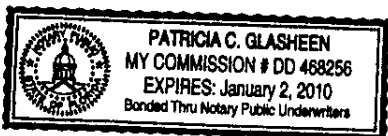


