ARTICLES OF ORGANIZATION

OF

SECRETARY SECTION These Articles of Organization of RED BANK INVESTMENTS, L.L.C., are being executed and filed to form a limited liability company pursuant to the Florida Limited liability Liability Company Act (the "Act").

the minimum number of votes that would be necessary to take such action at a meeting at which the holders of all membership interest entitled to vote on the action were present and voted.
