The undersigned does hereby execute these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

#### ARTICLE I

The name of the limited liability company shall be:

## ARTICLE II PERIOD OF DURATION

The period of duration of the Limited Liability Company shall be perpetual.

All powers of the limited liability company shall be exercised by or under the authority of, and the business and affairs of the limited liability company shall be managed by or under the direction of the manager of the limited liability company.
