The undersigned hereby makes, subscribes, and files these Articles of Organizations for the purpose of forming a limited liability company under the Florida Limited Liability Company Act:

- Name. The name of the limited liability company is THE HOTEL OF COLLINS AVENUE, LLC
- 2. <u>Duration.</u> The period of duration of the limited liability company is perpetual.
